RESOLUTION AUTHORIZING THE AWARD OF GRANTS FROM THE OPEN SPACE, FARMLAND AND HISTORIC PRESERVATION TRUST FUND PROGRAM FOR 2025 AS AUTHORIZED BY N.J.S.A. 40:12-15.2.

WHEREAS, the Board of County Commissioners of the County of Passaic (hereafter "Board") created an Open Space, Farmland and Historic Preservation Trust Fund Program (hereafter "Program") in conformity with the will of the voters in the 1996 election, as authorized by <u>N.J.S.A.</u> 40:12-15.2; and

WHEREAS, the purpose and goals of the above is to achieve, in partnership with others, a system of interconnected open spaces, whose protection will preserve and enhance New Jersey's natural environment and its historic, scenic, and recreational resources for public use and enjoyment; and

WHEREAS, pursuant to the mandates of the Program, the said Board did approve and appoint an Open Space, Farmland and Historic Preservation Trust Fund Advisory Committee (hereafter "the Committee") to study the open space issue and make recommendations concerning the distribution of funds to worthy applicants; and

WHEREAS, numerous municipalities and non-profit organizations submitted grant applications for funding under the 2025 Program rounding of funding; and

WHEREAS, the Committee has reviewed these grant proposals and has made recommendations for awards totaling three hundred thirty-five thousand and/100 (\$335,000.00) dollars; and

WHEREAS, the 2025 Program Application Recommendations, or awards not requiring a public hearing, are as follows:

NOW, THEREFORE, LET IT BE RESOLVED, pursuant to <u>N.J.S.A.</u> 40:12-15.2, the Board of County Commissioners of the County of Passaic hereby authorizes the award of grants from the Open Space, Farmland and Historic Preservation Trust Fund in an amount totaling three hundred thirty five thousand and 00/100 (\$335,000.00) dollars as stated above; and

LET IT BE FURTHER RESOLVED that all municipalities receiving funds must agree to place in their tax letter an insert that indicates that they received funds from the Passaic County Open Space, Farmland and Historic Preservation Trust Fund Program sponsored by the Board of County Commissioners of the County of Passaic; and
