WHEREAS, pursuant to Resolution R-25-489 dated May 27, 2025, the Board authorized the purchase of an annual software subscription for the Department of Senior Services, Disability &Veterans Affairs, Paratransit Division for calendar year 2025, as authorized by N.J.S.A. 40A:11-12; and

WHEREAS, the purpose of this Resolution is to reflect a correction in the title to state calendar year 2025 instead of 2024; and

WHEREAS, this matter was discussed at the May 20, 2025, meeting of the Health and Human Services Committee and is being recommended to the Board for approval; and
