

ORDINANCE NO. 2364-25

AN ORDINANCE TO FURTHER AMEND AND SUPPLEMENT CHAPTER 505, ARTICLE II, SECTIONS 505-5, SPEED LIMITS, SCHEDULE 505-54; AND 505-9, PROHIBITED RIGHT TURNS ON RED SIGNAL, SCHEDULE 505-59; SO AS TO ADD THERETO CERTAIN ADDITIONAL LOCATIONS

BE IT ORDAINED by the Municipal Council of the Borough of Hawthorne, in the County of Passaic and State of New Jersey, that:

Section 1. Chapter 505, Vehicles and Traffic, Article II, Section 505-5, Speed Limits, Schedule II, Section 505-54, shall be amended to add thereto the following additional locations:

Sec. 505-54, Schedule II, Section 505-54, Speed Limits

In accordance with the provisions of Sec. 505-5, speed limits are hereby established upon the following described streets or parts thereof:

<u>Name of Street</u>	<u>Speed Limit</u>	<u>Location</u>
Goffle Road	35	Entire Length

Section 2. Chapter 505, Vehicles and Traffic, Article II, Section 505-9, Prohibited Right Turns on Red, VI, Section 505-59, shall be amended to add thereto the following additional locations:

Sec. 505-59, Schedule VI: Prohibited Right Turns on Red Signal.

In accordance with the provisions of Sec. 505-9, no person shall make a right turn when facing a steady red signal (stop indication) at any of the following locations:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Rea Avenue	North	Goffle Road

Section 3. All other parts and provisions of Section 505, Schedules II, V and VI, not specifically affected by the above amendments and modifications shall remain in full force and effect.

Section 4. This Ordinance shall take effect twenty (20) days after final adoption and publication as provided by law.

NOTICE OF PENDING ORDINANCE


