- RESOLUTION INCREASING CONTRACT CEILING TO MCPIK RECOVERY UNDER RFP-24-006 FOR THE DEPARTMENT HUMAN SERVICES, DIVISION OF AND MENTAL HEALTH ADDICTION SERVICES, TO **PROVIDE** ADDICTION PREVENTION AND RECOVERY SUPPORT SERVICES IN 2025 TO PASSAIC COUNTY RESIDENTS, PURSUANT TO N.J.A.C. 5:30-11.6, ET SEQ.
- **WHEREAS**, the County of Passaic (the "County") is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq. and vested with all rights contained therein; and
- **WHEREAS**, pursuant to <u>N.J.S.A.</u> 40:20-1 the Board of County Commissioners for the County of Passaic (hereinafter the "Board") are vested with decision making powers on behalf of the County; and
- **WHEREAS,** the Department of Human Services (hereafter "Department"), Division of Mental Health and Addiction Services, provides addiction prevention and recovery support services for Passaic County residents; and
- **WHEREAS**, by Resolution No. R-24-1126, dated December 10, 2024, the Board authorized the first one (1) year option to renew for the calendar year 2025 to MCPIK Addiction Prevention and Recovery Support under RFP-24-006; and
- **WHEREAS**, the Director of the Department is requesting a Resolution to increase the contract ceiling of award to MCPIK by \$85,000, including a 10% administrative fee, in response to an increased level of services required; and
- **WHEREAS**, with this additional funding, MCPIK will provide substance-free transitional housing assistance of up to \$3,500 each to 22 Passaic County residents who suffer from or recover from substance use disorder or co-occurring disorder; and
- **WHEREAS,** MCPIK was originally awarded \$106,000 for Recovery Support under RFP-24-006 by Resolutions R-23-1142 and R-24-1126 dated December 12, 2023 and December 10, 2024, respectively; and
- WHEREAS, this adjustment will bring the total award amount to \$191,000 for MCPIK Recovery Support; and
- **WHEREAS**, pursuant to <u>N.J.A.C.</u> 5:30-11.6, the County can authorize contract modifications for professional services and extraordinary unspecifiable services, when the change is within the scope of activities of the original contract, and not for the purpose of undertaking new or different work or projects; and
- WHEREAS, pursuant to N.J.S.A. 52:32-60-1, et seq., vendor executed the Non-Involvement in Prohibited Activities in Russia or Belarus Certification, attached hereto and made part of this Resolution, certifying the vendor is not involved in prohibited activities in Russia and Belarus, and the County confirmed vendor is not identified on the Specially Designated Nationals and Blocked Persons list created by the Office of Foreign Assets Control; and
- WHEREAS, funds are available in Account No. G-01-41-736-025-213 or any other account that may be deemed appropriate by the Chief Financial Officer or his designee, and the availability of funds has been contingently certified by the Chief Financial Officer subject to sufficient funds being appropriated by the Board in the 2025 and/or subsequent years' County budget(s), which is attached to and made part of this Resolution; and
- **WHEREAS**, this matter was discussed at the April 1, 2025, meeting of the Health and Human Services Committee and is being recommended to the Board for approval; and
- NOW, THEREFORE, LET IT BE RESOLVED, pursuant to N.J.A.C. 5:30-11.6, et seq., the Board of County Commissioners of the County of Passaic (hereafter "Board") hereby authorizes the Department of Human Services, Division of Mental Health and Addiction Services, to increase the contract ceiling of the award under RFP-24-006 for MCPIK Recovery Support by \$85,000, including a 10% administrative fee, for a total award amount of \$191,000 to provide substance-free transitional housing assistance of up to \$3,500 each to 22 Passaic County residents who suffer from or recover from substance use disorder or co-occurring disorder; and

**LET IT BE FURTHER RESOLVED**, that the Clerk to the Board, County Counsel, the Director of the Board, and Chief Financial Officer for the County of Passaic are authorized to take all necessary action to carry out the purpose of this resolution.
