RESOLUTION TO AMEND RESOLUTION R-25-478, DATED MAY 27, 2025, TO ALLOCATE ADDITIONAL FUNDS TO TANF AND TO GA/SNAP, AND TO EXTEND THE TERM OF THE CONTRACT TO SEPTEMBER 30, 2025.

WHEREAS, the County of Passaic (hereafter “County”) is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq. and vested with all rights contained therein; and

WHEREAS, pursuant to N.J.S.A. 40:20-1, the Board of County Commissioners for the County of Passaic (hereafter the “Board”) is vested with decision making powers on behalf of the County; and

WHEREAS, pursuant to Resolution R-25-478, dated May 27, 2025, the Board authorized amendment of R-24-690, dated August 13, 2024, to allocate an additional \$96,000.00 to TANF and \$104,000.00 to GA/SNAP, totaling \$200,000.00, and to extend the term of the contract until September 30, 2025; and

WHEREAS, the purpose of this resolution is to amend same to reflect the correct contract extension period to September 30, 2025, which was incorrectly stated as September 25, 2025, in the body of Resolution R-25-478, dated May 27, 2025; and

NOW, THEREFORE, LET IT BE RESOLVED, the Board of County Commissioners of the County of Passaic hereby authorizes amendment of R-25-478, dated May 27, 2025, to correct the incorrect contract extension period of September 25, 2025, stated in the body of said Resolution and to reflect the correct contract extension period to September 30, 2025; and

LET IT BE FURTHER RESOLVED, that all the other terms and conditions as set forth in Resolution R-25-478, dated May 27, 2025, remain in full force and effect; and

LET IT BE FURTHER RESOLVED, that the Clerk to the Board, County Counsel, and the Director of the Department of Human Services are hereby authorized to take the necessary actions to carry out the purpose of this Resolution.
