## **RESOLUTION AUTHORIZING THE PURCHASE OF THREE (3) MVP3 WESTERN SNOWPLOWS FROM VAN DINES, INC., PURSUANT TO <u>N.J.S.A.</u> 40A: 11-12, <u>ET SEQ</u>.**

**WHEREAS**, the County of Passaic (hereafter "County") is a body politic and corporate pursuant to <u>N.J.S.A</u>. 40:18-1 and vested with all rights contained therein; and

WHEREAS, pursuant to <u>N.J.S.A</u>. 40:20-1 the Board of County Commissioners of the County of Passaic (hereafter "Board") is vested with managing the property, finances, and affairs of the County; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40:11-12, <u>et seq</u>., the County may, without advertising for bids, or having rejected all bids obtained pursuant to advertising thereof, purchase any goods or services under any contract or contracts for such goods or services entered into on behalf of the State of New Jersey by the Division of Purchase and Property in the Department of Treasury; and

WHEREAS, Van Dines, Inc., submitted competitive pricing under T0085 - Snow Plow Parts, And Grader and Loader Blades, to the State of New Jersey, Division of Purchase and Property in the Department of Treasury; and

WHEREAS, the Supervisor of Roads desires to purchase three (3) MVP3 Western Multi position snowplows from Van Dines Inc. d/b/a Van Dine Motors, Inc. in an amount not to exceed twenty-five thousand one hundred dollars and forty-nine cents (\$25,100.49) in accordance with the proposal, attached hereto and made part hereof; and

WHEREAS, funds are available in Account No. 5-0-44-900-003-000, or any other account that may be deemed appropriate by the Chief Financial Officer or his designee, and the availability of funds has been contingently certified by the Chief Financial Officer subject to sufficient funds being appropriated by the Board in the 2025 and/or subsequent years' County budget(s), which is attached to and made part of this Resolution; and

**WHEREAS,** this matter was discussed at the June 4, 2025 meeting of the Public Works Committee and is being recommended to the Board for approval.

**NOW, THEREFORE, LET IT BE RESOLVED**, pursuant to <u>N.J.S.A</u>. 40A:11-12, <u>et seq</u>. that the Board of County Commissioners of the County of Passaic authorizes the purchase of three (3) MVP3 Western Multi position snowplows from Van Dines Inc. d/b/a Van Dine Motors, Inc. in an amount not to exceed twenty-five thousand one hundred dollars and forty-nine cents (\$25,100.49), as recommended by the Supervisor of Roads.

LET IT BE FURTHER RESOLVED, that the Purchasing Agent, Clerk of the Board, and County Counsel are hereby authorized and directed to take such further actions and sign such documents as are necessary to effectuate the purpose of this Resolution, including but not limited to the issuance of the appropriate Purchase Order.
