

RESOLUTION AUTHORIZING A DECREASE IN FUNDING FOR PASSAIC COUNTY TECHNICAL-VOCATIONAL INSTITUTE BY \$60,000.00, DUE TO A REDUCTION OF SERVICES, PURSUANT TO N.J.S.A. 40:20-1

WHEREAS, the County of Passaic (hereafter “County”) is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq. and vested with all rights contained therein; and

WHEREAS, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners of the County of Passaic (hereafter “Board”) is vested with managing the property, finances, and affairs of the County; and

WHEREAS, the Department of Human Services (hereafter “Department”) is an umbrella social service agency concerned with planning and funding services for disadvantaged and homeless citizens; and

WHEREAS, the Director of the Department is requesting a resolution to decrease funding for Passaic County Technical-Vocational Institute by sixty thousand and 00/100 (\$60,000.00) dollars due a reduction of services; and

WHEREAS, the original award to Passaic County Technical-Vocational Institute was one hundred thousand and 00/100 (\$100,000.00) dollars, authorized by R-25-94, dated February 11, 2025; and

WHEREAS, after a reduction of sixty thousand and 00/100 (\$60,000.00) dollars, the new contract ceiling is forty thousand and 00/100 (\$40,000.00) dollars; and

WHEREAS, this matter was discussed for the June 10, 2025 meeting of Health and Human Services Committee and is being recommended to the Board for approval;

NOW, THEREFORE, LET IT BE RESOLVED, that, pursuant to N.J.S.A. 40:20-1, the Board of County Commissioners of the County of Passaic hereby authorizes a decrease in funding for Passaic County Technical-Vocational Institute by sixty thousand and 00/100 (\$60,000.00) dollars due to a reduction in services; and

LET IT BE FURTHER RESOLVED, that the Clerk to the Board, County Counsel, and Director of the Board of County Commissioners of the County of Passaic are authorized to take any other steps necessary to carry out the purpose of this resolution.
