Pursuant to N.J.S.A. 52:32-60 I, et seq. 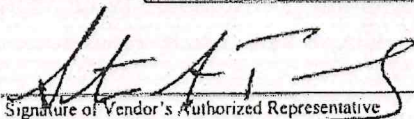

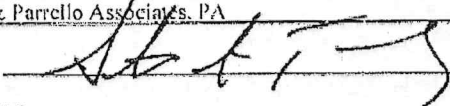
