



**CERTIFICATION OF NON-INVOLVEMENT IN PROHIBITED ACTIVITIES IN

Pursuant to N.J.S.A. 52:32-60.1, et seq. (L. 2012, c. 3) any person or entity (hereinafter "Vendor") that seeks to enter into or renew a contract with a State agency, including a local government agency, for the provision of goods or services, or the purchase of bonds or other obligations, must complete the certification below indicating whether or not the Vendor is identified on the Office of Foreign Assets Control (OFAC) Specially Designated Nationals and Blocked Persons list, available here: <https://www.treasury.gov/ofac/>.
