**RESOLUTION AUTHORIZING PURCHASE FROM PARAMUS FORD, INC., FOR A 2025 FORD POLICE INTERCEPTOR UTILITY AWD, PURSUANT TO N.J.S.A. 40A:11-10.**

**WHEREAS**, the County of Passaic (the “County”) is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq. and vested with all rights contained therein; and

**WHEREAS**, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners for the County of Passaic (hereinafter the “Board”) are vested with decision making powers on behalf of the County; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-10, the governing bodies of two or more contracting units may provide by a joint agreement for the provision of the performance of goods and services to be used by their respective jurisdictions; and

**WHEREAS**, by virtue of Resolution R20170119, the County entered into the Bergen County Cooperative Contract Purchasing System # 11-BCCPS, which awarded a contract for Cars, Crossovers, Class 1-3 Pickup Trucks Chassis SUVs and Vans, Bid No. BC-BID-24-43, to multiple vendors, including Paramus Ford, Inc.; and

**WHEREAS**, Paramus Ford, Inc., provided a quote to the Passaic County Sheriff’s Office, attached to and made part of this resolution, for the purchase of one (1) 2025 Ford Police Interceptor Utility AWD, in the amount of forty-seven thousand two hundred forty dollars and forty cents (\$47,240.40) which is being recommended for approval by the Passaic County Sheriff’s Office; and

**WHEREAS**, funds are available in Account No. T-13-56-860-000-801 or any other account that may be deemed appropriate by the Chief Financial Officer or his designee, and the availability of funds has been contingently certified by the Chief Financial Officer subject to sufficient funds being appropriated by the Board in the 2026 and/or subsequent years’ County budget(s), which is attached to and made part of this Resolution; and

**WHEREAS**, this matter was discussed at the February 3, 2026 meeting of the Law and Public Safety Committee and is being recommended to the Board for approval; and

**NOW, THEREFORE, LET IT BE RESOLVED**, pursuant to N.J.S.A. 40A:11-10, the Board of County Commissioners of the County of Passaic is authorizing a purchase from Paramus Ford, Inc., in the amount of forty-seven thousand two hundred forty dollars and forty cents (\$47,240.40), of one (1) 2025 Ford Police Interceptor Utility AWD, as recommended by the Passaic County Sheriff’s Office.

**LET IT BE FURTHER RESOLVED**, that the Director of the Board of County Commissioners, the Clerk to the Board, County Counsel, and Purchasing Agent are authorized to execute an agreement and take any other steps necessary to carry out the purpose of this resolution.
