**RESOLUTION AUTHORIZING THE PASSAIC COUNTY PURCHASING AGENT TO ADVERTISE AND RECEIVE BIDS FOR A CERTIFIED GOLF TEACHING PROFESSIONAL FOR THE PREAKNESS VALLEY GOLF COURSE IN THE TOWNSHIP OF WAYNE, PURSUANT N.J.S.A 40A: 11-23, ET SEQ.**

**WHEREAS** the County of Passaic (hereafter “County”) is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq. and vested with all rights contained therein; and

**WHEREAS**, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners for the County of Passaic (hereafter “Board”) is vested with decision-making powers on behalf of the County; and

**WHEREAS**, the County desires to hire a PGA-certified golf professional/instructor to provide training and instruction to patrons at Preakness Valley Golf Course in the Township of Wayne; and

**WHEREAS**, the Director of the Department of Parks & Recreation is recommending that the Board authorize the Purchasing Agent to advertise and receive bids for a certified golf teaching professional for Preakness Valley Golf Course; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-23, et seq. the County will publish the advertisement for bids in advance of the date fixed for receiving the bids to promote competitive bidding; and

**WHEREAS**, this matter was discussed at January 10, 2024, meeting of the Public Works Committee and is being recommended to the Board for approval.

**NOW, THEREFORE, LET IT BE RESOLVED**, pursuant to N.J.S.A. 40A:11-23, et seq., that the Passaic County Board of Commissioners hereby authorizes the Passaic County Purchasing Agent to advertise and receive bids as recommended by the Director of the Department of Parks & Recreation Affairs for a certified golf teaching professional for Preakness Valley Golf Course in the Township of Wayne.
