Management- 30 points, Technical -50 points and Cost -20 points

Committee feedback and analysis: The applicant provided good detail with regard to the number of rides to be provided under the grant. The applicant provided a complete budget that was cost effective. This application is from an organization with a positive history of providing this type of service for the county.

Total Composite Score: 63
