## RESOLUTION AMENDING RESOLUTION R-24-144, AUTHORIZING THE PURCHASE OF BLOOD CONTROL TRAINING CLASSES BY THE PASSAIC COUNTY OFFICE OF EMERGENCY MANAGEMENT, TO INCREASE THE CONTRACT AWARD FROM \$15,000.00 TO \$16,066.72 PURSUANT TO <u>N.J.S.A</u>. 40A:11-10

**WHEREAS**, the County of Passaic (the "County") is a body politic and corporate pursuant to <u>N.J.S.A.</u> 40:18-1 and vested with all rights contained therein; and

**WHEREAS**, pursuant to <u>N.J.S.A.</u> 40:20-1 the Board of County Commissioner of the County of Passaic (the "Board") is vested with managing the property, finances, and affairs of the County; and

WHEREAS, on November 18, 2024, the Board adopted Resolution R 24-144 authorizing the Passaic County Office of Emergency Management ("OEM") to purchase Blood Control Training Classes for the Passaic County First Responders from Penn Tactical Solutions, LLC, in an amount not to exceed fifteen thousand dollars (\$15,000.00); and

WHEREAS, the services provided by Penn Tactical Solutions, LLC, exceeded the contract award under Resolution R24-144 by one thousand sixty-six dollars and seventy cents (\$1,066.72); and

WHEREAS, the OEM seeks to amend Resolution R 24-144 to increase the funding award by one thousand sixty-six dollars and seventy- two cents (\$1,066.72) to account for the services rendered by Penn Tactical Solutions, LLC, increasing the total contract award to sixteen thousand sixty-six dollars and seventy- two cents (\$16,066.72); and

WHEREAS, the requested increase funding under this Resolution will be withdrawn from the State Homeland Security Grant under account number FY23 UASI: G-01-41-846-023-223; and

**WHEREAS,** this matter has been reviewed by the Law and Public Safety Committee, on April 1, 2025, and is recommended to the Board of for approval; and

**NOW, THEREFORE, LET IT BE RESOLVED,** that the Board of County Commissioners for the County of Passaic hereby authorizes an amendment to Resolution R 24-144 to increase the contract award amount to one thousand sixty-six dollars and seventy cents (\$1,066.72) for the additional services provided by Penn Tactical Solutions, LLC, increasing the total contract award to sixteen thousand sixty-six dollars and seventy- two cents (\$16,066.72).

**LET IT BE FURTHER RESOLVED**, the requested increase funding under this Resolution will be withdrawn from the State Homeland Security Grant under account number FY23 UASI: G-01-41-846-023-223.

LET IT BE FURTHER RESOLVED, that all the other terms and conditions as set forth in Resolution R-24-144 remain in full force and effect.

LET IT BE FURTHER RESOLVED, that the Clerk of the Board, County Counsel, County Administrator, Passaic County Office of Management, and Director of the Board of County Commissioners are authorized to execute an agreement and take any other steps necessary to carry out the purpose of this resolution.
