**RESOLUTION TO ACCEPT THE REVISED ALLOCATION OF COMMUNITY SERVICES BLOCK GRANT NON-DISCRETIONARY FUNDING FOR FY2025 FROM THE DEPARTMENT OF COMMUNITY AFFAIRS, DIVISION OF HOUSING AND COMMUNITY RESOURCES.**

**WHEREAS**, the County of Passaic (the “County”) is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq. and vested with all rights contained therein; and

**WHEREAS**, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners for the County of Passaic (hereinafter the “Board”) are vested with decision-making powers on behalf of the County; and

**WHEREAS**, the Department of Human Services (hereafter “Department”) is an umbrella social service agency concerned with planning and funding services for disadvantaged and homeless citizens; and

**WHEREAS**, the Director of the Department of the Board of County Commissioners of the County of Passaic authorizes the Department of Human Services to accept the revised allocation of the Community Services Block Grant from the Department of Community Affairs, Division of Housing and Community Resources; and

**WHEREAS**, the full anticipated allocation was established under R24-689 on August 13, 2024, for the amount of three hundred twelve thousand four hundred sixty and 00/100 (\$312,460.00) dollars;

**WHEREAS**, the revised allocation is for a total of three hundred twenty-seven thousand eight hundred three and 00/100 (\$327,803.00) and is available from January 1, 2025, to September 30, 2026, and the third and final allocation is in the amount of one hundred sixty-six thousand six hundred seventy-six and 00/100 (\$166,676.00) dollars; and

**WHEREAS**, this matter was discussed at the June 10, 2025, meeting of the Health and Human Services Committee and is being recommended to the Board for approval; and

**NOW, THEREFORE, LET IT BE RESOLVED**, pursuant to N.J.S.A. 40A:11-4.1, et seq., the Board of County Commissioners of the County of Passaic authorizes the Department of Human Services to accept the revised allocation of the Community Services Block Grant from the Department of Community Affairs, Division of Housing and Community Resources; and

**LET IT BE FURTHER RESOLVED**, that the Clerk to the Board, Director of the Board, County Counsel and Director of the Board of County of Commissioners are authorized to take any other steps necessary to carry out the purpose of this Resolution.
