

**RESOLUTION TO AMEND RESOLUTION R-25-479, DATED MAY 27, 2025, TO ALLOCATE ADDITIONAL FUNDS FOR TANF AND FOR GA/SNAP FOR CAREER SERVICES UNDER RFP 22-018, AND TO AMEND RESOLUTION R-24-881, DATED OCTOBER 8, 2024, TO ALLOCATE ADDITIONAL FUNDS FOR TANF AND FOR GA/SNAP FOR ONE STOP OPERATIONS BY THE PASSAIC COUNTY WORKFORCE DEVELOPMENT CENTER UNDER RFP 24-031, AND TO EXTEND THE TERM OF THE CONTRACT TO SEPTEMBER 30, 2025.**

**WHEREAS**, the County of Passaic (hereafter “County”) is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq. and vested with all rights contained therein; and

**WHEREAS**, pursuant to N.J.S.A. 40:20-1, the Board of County Commissioners for the County of Passaic (hereafter the “Board”) is vested with decision making powers on behalf of the County; and

**WHEREAS**, pursuant to Resolution R-25-479, dated May 27, 2025, the Board authorized amendment of R-24-691, dated August 13, 2024, to allocate an additional \$227,658.00 for TANF and \$273,342.00 for GA/SNAP, totaling \$501,000.00, and to extend the term of the contract until September 30, 2025; and

**WHEREAS**, the purpose of this resolution is to amend same to allocate an additional \$214,144.00 for TANF and an additional \$255,604.00 for GA/SNAP, totaling an additional \$469,748.00 for Career Services under RFP 22-018; and

**WHEREAS**, pursuant to Resolution R-24-881, dated October 8, 2024, the Board authorized an award of contract to the Passaic County Workforce Development Center for One Stop Career Center Operations Management Services for the period of November 1, 2024, to June 30, 2025; and

**WHEREAS**, the purpose of this resolution is to amend same to allocational an additional \$13,514.00 for TANF and an additional \$17,738.00 for GA/SNAP, totaling an additional \$31,252.00 for One Stop Operations by the Passaic County Workforce Development Center and to extend the term of the contract until September 30, 2025, as per the attached contract extension award granted by the NJ Department of Labor and Workforce Development; and

**WHEREAS**, funds are available in Account Nos. G-01-041-725-024-PE1 and G-01-041-726-024-PE1 or any other account that may be deemed appropriate by the Chief Financial Officer or his designee, and the availability of funds has been contingently certified by the Chief Financial Officer subject to sufficient funds being appropriated by the Board in the 2025 and/or subsequent years’ County budget(s); and

**WHEREAS**, pursuant to N.J.S.A. 52:32-60-1, et seq., vendor executed the Non-Involvement in Prohibited Activities in Russia or Belarus Certification, attached hereto and made part of this Resolution, certifying the vendor is not involved in prohibited activities in Russia and Belarus, and the County confirmed vendor is not identified on the Specially Designated Nationals and Blocked Persons list created by the Office of Foreign Assets Control; and

**WHEREAS**, this matter was discussed at the June 10, 2025, meeting of the Health and Human services Committee and is being recommended to the Board for approval; and

**NOW, THEREFORE, LET IT BE RESOLVED**, the Board of County Commissioners of the County of Passaic hereby authorizes amendment of R-25-479, dated May 27, 2025, to allocate an additional \$214,144.00 for TANF and an additional \$255,604.00 for GA/SNAP, totaling an additional \$469,748.00 for Career Services under RFP 22-018; and

**LET IT BE FURTHER RESOLVED**, the Board of County Commissioners of the County of Passaic hereby authorizes amendment of R-24-881, dated October 8, 2024, to allocate an additional \$13,514.00 for TANF and an additional \$17,738.00 for GA/SNAP, totaling an additional \$31,252.00 for One Stop Operations by the Passaic County Workforce Development Center under RFP-24-031 and to extend the term of the contract until September 30, 2025; and

**LET IT BE FURTHER RESOLVED**, that all the other terms and conditions as set forth in Resolution R-25-479, dated May 27, 2025, and in Resolution R-24-881, dated October 8, 2024, remain in full force and effect; and

**LET IT BE FURTHER RESOLVED**, that the Clerk to the Board, County Counsel, and the

Director of the Department of Human Services are hereby authorized to take the necessary actions to carry out the purpose of this Resolution.
