**RESOLUTION AUTHORIZING THE PURCHASE OF GOODS BY THE PASSAIC COUNTY
OFFICE OF EMERGENCY MANAGEMENT PURSUANT TO N.J.S.A. 40A:11-12**

WHEREAS, the County of Passaic (the “County”) is a body politic and corporate pursuant to N.J.S.A. 40:18-1 and vested with all rights contained therein; and

WHEREAS, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners of the County of Passaic (the “Board”) is vested with managing the property, finances, and affairs of the County; and

WHEREAS, the Passaic County Office of Emergency Management (“OEM”) has requested to purchase goods from a qualified vendor for use in furtherance of its law enforcement and/or administrative objectives and/or those of various law enforcement agencies within the County; and

WHEREAS, said services are being procured through Federal GSA as permitted by the Local Public Contracts Law, N.J.S.A. 40A:11-12; and

WHEREAS, said purchases are to be funded directly through the FY23-UASI Homeland Security Grant; and

WHEREAS, the Board of County Commissioners of the County of Passaic (the “Board”) is desirous of approving said purchases in accordance with the terms of the applicable GSA contract, and authorizing the Purchasing Agent to issue the appropriate Purchase Orders; and

WHEREAS, this matter was discussed at the April 14, 2025, meeting of the Law and Public Safety Committee and is being recommended to the Board for approval; and

WHEREAS, funds are available in the accounts set forth below or any other account that may be deemed appropriate by the Chief Financial Officer or his designee, and the availability of funds has been contingently certified by the Chief Financial Officer subject to sufficient funds being appropriated by the Board in 2025 and/or subsequent years’ County budget(s), which is attached to and made part of this Resolution; and

WHEREAS, this matter was discussed at the April 14, 2025, meeting of the Law and Public Safety Committee and is being recommended to the Board for approval; and

NOW, THEREFORE, LET IT BE IT RESOLVED, pursuant N.J.S.A. 40A:11-12, et. seq., the Board of County Commissioners of the County of Passaic hereby authorizes the purchases of the following goods or services in accordance with the terms of the applicable state or cooperative agreement:
