**RESOLUTION AMENDING RESOLUTION R-25-362, AUTHORIZING THE PURCHASE OF AN ANNUAL MAINTENANCE CONTRACT FOR THE PASSAIC COUNTY SHERIFF'S OFFICE TO INDICATE THE PASSAIC COUNTY PROSECUTOR'S OFFICE AS THE USING AGENCY INSTEAD OF THE SHERIFF'S OFFICE**

**WHEREAS**, the County of Passaic (the "County") is a body politic and corporate pursuant to N.J.S.A. 40:18-1 and vested with all rights contained therein; and

**WHEREAS**, pursuant to N.J.S.A. 40:20-1, the Board of County Commissioners of the County of Passaic (the "Board") is vested with managing the property, finances, and affairs of the County; and

**WHEREAS**, on April 8, 2025, the Board adopted Resolution R 25-362 authorizing the purchase of an annual maintenance contract from Mutualink, Inc., covering the period of March 28, 2025, through March in the amount of thirty-four thousand, seven hundred fifty-seven dollars; and

**WHEREAS**, Resolution R-25-362 incorrectly listed the Passaic Sheriff's Office as the agency requesting said services; and

**WHEREAS**, Resolution R-25-362 needs to be amended to indicate that the Passaic County Prosecutor's Office is the agency requesting the annual maintenance contract from Mutualink, Inc., instead of the Passaic County Sheriff's Office.

**NOW, THEREFORE, LET IT BE RESOLVED**, that the Board of County Commissioners for the County of Passaic hereby authorizes an amendment to Resolution R-25-362 needs to be amended to indicate that the Passaic County Prosecutor's Office is the agency requesting the annual maintenance contract from Mutualink, Inc.

**LET IT BE FURTHER RESOLVED**, that all the other terms and conditions as set forth in Resolution R-25-362 remain in full force and effect.

**LET IT BE FURTHER RESOLVED**, that the Clerk of the Board, County Counsel, County Administrator, Passaic County Prosecutor's Office, and Director of the Board of County Commissioners are authorized to execute an agreement and take any other steps necessary to carry out the purpose of this resolution.
