## **RESOLUTION AMENDING THE 2025 OPEN SPACE, FARMLAND, AND HISTORIC PRESERVATION TRUST FUND BUDGET, PURSUANT TO N.J.S.A. 40:20-1**

**WHEREAS**, the County of Passaic (the "County") is a government body incorporated pursuant to <u>N.J.S.A.</u> 40:18-1, <u>et seq</u>. and vested with all rights contained therein; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40:20-1 the Board of Chosen Freeholders for the County of Passaic (hereinafter the "Board") is vested with decision making powers on behalf of the County; and

**WHEREAS**, on April 25,2017, the Board approved Resolution No. R20170349, adopting a uniform body of rules and regulations governing the Open Space, Farmland, and Historic Preservation trust Fund("Rules"); and

**WHEREAS**, Chapter 17 of the Rules requires the Board to pass a yearly budget for appropriations from the Open Space, Farmland, and Historic Preservation Trust Fund, outlining improvement projects and other allowable expenses within the Passaic County Park System; and

WHEREAS, the Board did adopt a budget on February 11, 2025.

WHEREAS, new information on projects have been received and evaluated and there is a need to amend the adopted Open Space budget by \$215,000 for expenses related to the Peckman Preserve Improvement Project and \$133,000 for salaries of Cultural & Historical Affairs staff. All of the funds will be appropriated from the General Open Space Trust Funds except for \$20,000 which will be appropriated from the Municipal/Nonprofit Open Space Trust Funds; and

**WHEREAS**, this matter was discussed at the May 28, 2025 meeting of the Administration and Finance Committee and is being recommended to the Board for approval; and

**NOW, THEREFORE, LET IT BE RESOLVED**, pursuant to <u>N.J.S.A</u>. 40:20-1 that the Board of County Commissioners of the County of Passaic authorizes amendments to the Open Space, Farmland, and Historic Preservation Trust Fund for \$215,000 for expenses related to the Peckman Preserve Improvement Project and \$133,000 for salaries of Cultural & Historical Affairs staff. All of the funds will be appropriated from the General Open Space Trust Funds except for \$20,000 which will be appropriated from the Municipal/Nonprofit Open Space Trust Funds; and

**LET IT BE FURTHER RESOLVED** that the Chief Financial Officer and County Treasurer are authorized to take any action necessary to carry out the purpose of this resolution.
