**RESOLUTION AUTHORIZING THE CHIEF FINANCIAL OFFICER TO REQUEST APPROVAL OF ITEMS OF REVENUE AND APPROPRIATION PURSUANT TO NJSA 40A:4-87 (Chapter 159 P.L. 158)**

**WHEREAS** the County of Passaic (hereafter “County”) is a body politic and corporate pursuant to N.J.S.A. 40:18-1 and vested with all rights contained therein; and

**WHEREAS**, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners of the County of Passaic (hereafter “Board”) is vested with managing the property, finances, and affairs of the County; and

**WHEREAS**, pursuant to N.J.S.A. 40A:4-87, the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any local unit when such item shall have been made available by any public or private funding source and the amount thereof shall not have been determined at the time of the adoption of the budget, and may approve the insertion of an appropriation item of an amount equal to any such special item of revenue making such item of revenue available for expenditure; and

**WHEREAS** the County desires to anticipate and appropriate a sum of \$8,696.72 for the program as noted below; and

**NOW, THEREFORE, LET IT BE RESOLVED**, that the Board of County Commissioners of the County of Passaic hereby requests that the Director of the Division of Local Government Services approves the insertion of an additional item of revenue in the budget of the County of Passaic for calendar year 2026 in the sum of \$8,696.72, which is now available as revenue from a grant award from the New York/New Jersey 2026 World Cup Host Committee, Inc, FIFA World Cup Grant Program, in accordance with the law.

**LET IT BE FURTHER RESOLVED** that a like sum of \$8,696.72 be and the same is hereby appropriated under the caption which item is now available as revenue from a grant award from the New York/New Jersey 2026 World Cup Host Committee, Inc, FIFA World Cup Grant Program [EMW-2026-WC-05002].

**LET IT BE FURTHER RESOLVED** that an electronic copy of this Resolution be forwarded to the Division of Local Government Services.
