**RESOLUTION AUTHORIZING THE REAPPOINTMENT OF ERIN MOONEY AS THE COUNTY TREASURER EFFECTIVE APRIL 23, 2025 AND EXPIRING APRIL 22, 2028, PURSUANT TO N.J.S.A. 40A:9-27**

**WHEREAS**, the County of Passaic (hereafter “County”) is a body politic and corporate pursuant to N.J.S.A. 40:18-1 and vested with all rights contained therein; and

**WHEREAS**, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners of the County of Passaic (hereafter “Board”) is vested with managing the property, finances, and affairs of the County; and

**WHEREAS**, pursuant to N.J.S.A. 40A:9-27, the Board shall appoint a County Treasurer for a term of three (3) years, who shall be the custodian of all county funds and disburse said funds only on the order of the Board, and undertake other duties, as prescribed under the law; and

**WHEREAS**, on May 24, 2022, the Board approved Resolution No. R-22-0404, authorizing the reappointment of Erin Mooney to a three-year term as the County Treasurer effective April 23, 2022 and expiring April 22, 2025, in accordance with the law; and

**WHEREAS**, the Board desires to reappoint Erin Mooney to a full term as County Treasurer, effective retroactively on April 23, 2025 and expiring April 22, 2028; and

**WHEREAS**, this matter was discussed at the April 9, 2025 Administration and Finance Committee meeting, and is being recommended to the Board for approval.

**NOW, THEREFORE, LET IT BE RESOLVED**, pursuant to N.J.S.A. 40A:9-27 the Board of County Commissioners of the County of Passaic reappoints Erin Mooney as the County Treasurer for a full term beginning on April 23, 2025 and expiring on April 22, 2028.

**LET IT BE FURTHER RESOLVED** that the Clerk of the Board, County Counsel, and Director of the Board of County Commissioners are authorized to take any other action necessary to carry out the purposes of this Resolution.
