**RESOLUTION AUTHORIZING AND AWARDING A NO-COST EXTENSION FOR THE DEPARTMENT OF HUMAN SERVICES, JUVENILE ADMINISTRATION DIVISION TO NEW DESTINY FAMILY SUCCESS CENTER FOR RESTORATIVE AND TRANSFORMATIVE JUSTICE FOR YOUTH AND COMMUNITIES PILOT PROGRAM.**

**WHEREAS**, the County of Passaic (hereafter “County”) is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq. and vested with all rights contained therein; and

**WHEREAS**, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners for the County of Passaic (hereafter the “Board”) are vested with decision-making powers on behalf of the County; and

**WHEREAS**, the Department of Human Services (hereafter “Department”) is an umbrella social service agency concerned with planning and funding services for disadvantaged and homeless citizens; and

**WHEREAS**, pursuant to Resolution R-23-0400, dated April 25, 2023, the Board of County Commissioners of the County of Passaic (hereafter “Board”) authorized the Department of Human Services to award a contract to New Destiny Family Success Center for Restorative and Transformative Justice for Youth and Communities Pilot Program Grant, RFP-22-025, in the amount of One Million Six Hundred Forty-Two Thousand Two Hundred and 00/100 (\$1,642,200.00) for a term commencing April 25, 2023 through October 31, 2024 with two (2) one-year options to renew; and

**WHEREAS**, pursuant to Resolution R-24-510, dated June 11, 2024, the Board authorized the first no-cost time extension to change the end date of this program to June 30, 2025; and

**WHEREAS**, the Director of the Department is requesting a resolution authorizing a no-cost time extension to June 30, 2026; and

**WHEREAS**, pursuant to N.J.S.A. 52:32-60-1, et seq., vendor executed the Non-Involvement in Prohibited Activities in Russia or Belarus Certification, attached hereto and made part of this Resolution, certifying the vendor is not involved in prohibited activities in Russia and Belarus, and the County confirmed vendor is not identified on the Specially Designated Nationals and Blocked Persons list created by the Office of Foreign Assets Control; and

**WHEREAS**, this matter was discussed at the June 10, 2025 meeting of the Health and Human Services Committee and is being recommended to the Board for approval; and

**NOW, THEREFORE, LET IT BE RESOLVED**, the Board of County Commissioners of the County of Passaic (hereafter “Board”) hereby authorizes and awards a no-cost time extension for the Department of Human Services, Juvenile Administration Division to New Destiny Family Success Center for Restorative and Transformative Justice for Youth and Communities Pilot Program to June 30, 2026; and

**LET IT BE FURTHER RESOLVED**, that the Clerk to the Board, Director of the Board, County Counsel, and Director of the Department of Human Services are authorized to take any other steps necessary to carry out the purpose of this Resolution.
