

RESOLUTION AUTHORIZING THE PASSAIC COUNTY PURCHASING AGENT TO ADVERTISE AND RECEIVE BIDS FOR THE LAMBERT CASTLE LANDSCAPE RESTORATION PHASE II AT LAMBERT CASTLE IN THE CITY OF PATERSON, PURSUANT N.J.S.A. 40A: 11-23, ET SEQ.

WHEREAS, the County of Passaic (hereafter “County”) is a body politic and corporate pursuant to N.J.S.A. 40:18-1 and vested with all rights contained therein; and

WHEREAS, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners for the County of Passaic (hereafter “Board”) is vested with decision making powers on behalf of the County; and

WHEREAS, the Director of the Department of Cultural & Historic Affairs desires to undertake a project for landscape restoration at Lambert Castle in the City of Paterson; and

WHEREAS, the Director of the Department of Cultural & Historic Affairs is recommending that the Board authorize the Purchasing Agent to advertise and receive bids for the Lambert Castle Landscape Restoration Phase II at Lambert Castle in the City of Paterson; and

WHEREAS, pursuant to N.J.S.A. 40A:11-23, et seq. the County shall publish the advertisement for bids in advance of the date fixed for receiving the bids to promote competitive bidding; and

WHEREAS, this matter was discussed at the April 30, 2025 meeting of the Public Works Committee and is being recommended to the Board for approval.

NOW, THEREFORE, LET IT BE RESOLVED, pursuant to N.J.S.A. 40A:11-23, et seq., that the Passaic County Board of Commissioners hereby authorizes the Passaic County Purchasing Agent to advertise and receive bids as recommended by the Director of the Department of Cultural & Historic Affairs for the Lambert Castle Landscape Restoration Phase II in the City of Paterson.
