- RESOLUTION AUTHORIZING AN AWARD OF CONTRACT TO MIVILA CORP. D/B/A MIVILA FOODS, FOR THE PROVISION OF A VARIETY OF LIQUID THICKENERS TO PREAKNESS HEALTHCARE CENTER, PURSUANT TO N.J.S.A. 40A:11-4.
- **WHEREAS**, the County of Passaic (hereafter "County") is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq. and vested with all rights contained therein; and
- **WHEREAS**, pursuant to <u>N.J.S.A.</u> 40:20-1, the Board of County Commissioners for the County of Passaic (hereafter the "Board") is vested with decision-making powers on behalf of the County; and
- **WHEREAS**, Preakness Healthcare Center (hereafter "Preakness") is a New Jersey Department of Health licensed, 406-bed skilled nursing facility that is owned and operated by the Board; and
- **WHEREAS**, pursuant to <u>N.J.S.A.</u> 40A:11-4. for every contract awarded by the County for the provision or performance of any goods or services, the cost of which in the aggregate exceeds the bid threshold established pursuant to N.J.S.A. 40A:11-3, shall be awarded by resolution of the Board to the lowest responsible bidder after public advertising for bids and bidding thereof; and
- **WHEREAS**, on April 21, 2025, the Purchasing Agent issued SB-25-058, Preakness Healthcare Center Thicken Liquids Varieties ("SB-25-058"), in compliance with N.J.S.A. 40A:11-4, soliciting competitive pricing from qualified vendors for the goods and services sought therein; and
- **WHEREAS**, on May 2, 2025, the Purchasing Agent unsealed responses received to SB-25-058; and
- WHEREAS, the Executive Director of Preakness is recommending that the Board authorize a contract with Mivila Corp. d/b/a Mivila Foods to provide a variety of liquid thickeners to Preakness, during a term beginning on July 18, 2025 and ending on June 30, 2027, for a total amount not to exceed one hundred fifty thousand dollars (\$150,000.00), in accordance with the terms and conditions set forth in SB-25-058; and
- WHEREAS, pursuant to N.J.S.A. 19:44A-20.4, this contract is being awarded under a fair and open procurement process, which requires that a contract be: publicly advertised in sufficient time to give notice in advance of the contract; awarded under a process that provides for public solicitation of proposals or qualifications; awarded and disclosed under criteria established in writing by the public entity prior to the solicitation of proposals or qualifications; and publicly opened and announced when awarded; and
- WHEREAS, pursuant to N.J.S.A. 52:32-60-1, et seq., Mivila Corp. d/b/a Mivila Foods executed the Non-Involvement in Prohibited Activities in Russia or Belarus Certification, attached hereto and made part of this Resolution, certifying that it is not involved in prohibited activities in Russia and Belarus, and the County confirmed that said vendor is not identified on the Specially Designated Nationals and Blocked Persons list created by the Office of Foreign Assets Control; and
- **WHEREAS**, funds are available in Account No. 5-01-27-172-001-F04, or any other account that may be deemed appropriate by the Chief Financial Officer or his designee, and the availability of funds has been contingently certified by the Chief Financial Officer subject to sufficient funds being appropriated by the Board in the 2025 and/or subsequent years' County budget(s); and
- **WHEREAS**, this matter was discussed at the June 10, 2025, meeting of the Health and Human Services Committee and is being recommended to the Board for approval.
- **NOW, THEREFORE, LET IT BE RESOLVED**, pursuant to N.J.S.A. 40A:11-4, the Board of County Commissioners of the County of Passaic hereby authorizes the award of a contract to Mivila Corp. d/b/a Mivila Foods to provide a variety of liquid thickeners to Preakness Healthcare Center, pursuant to the terms and conditions of SB-25-058, Preakness Healthcare Center Thicken Liquids Varieties, during a term beginning on July 18, 2025 and ending on June 30, 2027, for a total amount not to exceed one hundred fifty thousand dollars (\$150,000.00).
- **LET IT BE FURTHER RESOLVED**, that the Clerk to the Board, County Counsel, Purchasing Agent, Executive Director of Preakness, and Director of the Board are authorized to take any other steps necessary to carry out the purpose of this Resolution.
