RESOLUTION AUTHORIZING AN AWARD OF CONTRACT TO ACCURATE WELL & PUMP LLC OF WEST MILFORD FOR WATER WELL DECOMMISSIONING AT PREAKNESS VALLEY GOLF COURSE, PURSUANT TO N.J.S.A. 40A:11-3

WHEREAS, the County of Passaic (hereafter “County”) is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq. and vested with all rights contained therein; and

WHEREAS, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioners for the County of Passaic (hereafter “Board”) are vested with decision making powers on behalf of the County; and

WHEREAS, pursuant to N.J.S.A. 40A:11-3(c), the Governor, in consultation with the Department of Treasury, shall, no later than March 1 of every fifth year beginning in the fifth year after the year in which P.L. 1999, c.440 takes effect, adjust the [bid] threshold amount, in direct proportion to the rise or fall of the index rate as the term is defined in section N.J.S.A. 40A:11-2, and shall round the adjustment to the nearest \$1,000; and

WHEREAS, on June 30, 2020 the Board approved Resolution No. R20200514 setting the bid threshold at forty-four thousand dollars (\$44,000.00), in accordance with the law; and

WHEREAS, the Director of the Department of Parks & Recreation has determined that the decommissioning of a water well located at the Preakness Valley Golf Course at 209 Totowa Road, Wayne, New Jersey, is required so it does not affect the timeline for construction of the new maintenance facility; and

WHEREAS, Accurate Well & Pump LLC of West Milford, New Jersey, provided a quote to the Director of the Department of Parks & Recreation to decommission the water well located at the Preakness Valley Golf Course at 209 Totowa Road, Wayne, New Jersey, in a total amount not to exceed fourteen thousand four hundred dollars (\$14,400.00), which is being recommended for Board approval by the Director of the Department of Parks & Recreation; and

WHEREAS, Accurate Well & Pump LLC, has executed a Business Entity Disclosure Certification for Non-Fair and Open Contracts pursuant to N.J.S.A. 19:44A-20.8, stating that Direct Supply has not made and will not make any reportable contributions pursuant to N.J.S.A. 19:44A-1, et seq. that would bar award of this contract, which is attached hereto and made part of this resolution; and

WHEREAS, funds are available in Account No. C-04-55-188-001-901 or any other account that may be deemed appropriate by the Chief Financial Officer or his designee, and the availability of funds has been contingently certified by the Chief Financial Officer subject to sufficient funds being appropriated by the Board in the 2024 and/or subsequent years’ County budget(s), which is attached to and made part of this Resolution; and

WHEREAS, this matter was discussed at the February 26, 2025, meeting of the Public Works Committee, and is being recommended to the Board for approval; and

NOW, THEREFORE LET IT BE RESOLVED, pursuant to N.J.S.A. 40A:11-3, the Board of County Commissioners of the County of Passaic authorizes an award of contract to Accurate Well & Pump LLC, in a total amount not to exceed fourteen thousand four hundred dollars (\$14,400.00) to decommission the water well located at the Preakness Valley Golf Course at 209 Totowa Road, Wayne, New Jersey, as recommended by the Director of the Department of Cultural & Historic Affairs.

LET IT BE FURTHER RESOLVED, the Clerk to the Board shall print, in the official newspaper, a brief notice stating the nature, duration, service, and amount of the contract to Accurate Well & Pump LLC, and maintain a copy of the resolution on file and available for public inspection in the Office of the Clerk to the Board.

LET IT BE FURTHER RESOLVED, that the Clerk to the Board, County Counsel, and the Director of the Board are authorized to take any other steps necessary to carry out the purpose of this resolution.
