**RESOLUTION CONCURRING WITH ORDINANCE NO. 29 (YEAR 2025) OF THE TOWNSHIP OF WAYNE, PURSUANT TO N.J.S.A. 40:20-1 ET SEQ.**

**WHEREAS**, the County of Passaic (hereafter “County”) is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq. and vested with all rights contained therein; and

**WHEREAS**, pursuant to N.J.S.A. 40:20-1, the Board of County Commissioners for the County of Passaic (hereafter “Board”) is vested with decision making powers on behalf of the County; and

**WHEREAS**, the County is responsible for the maintenance of Paterson-Hamburg Turnpike in the Township of Wayne; and

**WHEREAS**, the Township of Wayne has adopted Ordinance No. 29 dated April 16, 2025, attached hereto and made part hereof, which approves a traffic signal at the Paterson-Hamburg Turnpike and the Plaza Square Access Driveway; and

**WHEREAS**, the County Engineer is recommending that the Board concur with the decision of the Township of Wayne to adopt Ordinance No. 29; and

**WHEREAS**, this matter was discussed at the April 30, 2025, meeting of the Public Works Committee and is being recommended to the Board for approval; and

**NOW, THEREFORE, LET IT BE RESOLVED**, pursuant to N.J.S.A. 40:20-1 et seq. that the Board of County Commissioners of the County of Passaic hereby concurs with Ordinance No. 29 dated April 16, 2025 passed by the Township of Wayne.

**LET IT BE FURTHER RESOLVED**, that the Clerk of the Board, County Counsel, and Director of the Board of County Commissioners are authorized to execute the contract and take any other steps necessary to carry out the purpose of this resolution.
