WHEREAS, the Township of Wayne has adopted Ordinance No. 29 dated April 16, 2025, attached hereto and made part hereof, which approves a traffic signal at the Paterson-Hamburg Turnpike and the Plaza Square Access Driveway; and

WHEREAS, the County Engineer is recommending that the Board concur with the decision of the Township of Wayne to adopt Ordinance No. 29; and

WHEREAS, this matter was discussed at the April 30, 2025, meeting of the Public Works Committee and is being recommended to the Board for approval; and
