RESOLUTION AUTHORIZING AGREEMENT WITH UNIVERSITY HOSPITAL NEWARK FOR PROVISION OF MOBILE MAMMOGRAPHY SERVICES AT THE COUNTY'S WOMEN'S HEALTH EXTRAVAGANZA, PURSUANT TO N.J.S.A. 40:20-1

**WHEREAS**, the County of Passaic ("County") is a body politic and corporate pursuant to N.J.S.A. 40:18-1 and vested with all rights contained therein; and

**WHEREAS**, pursuant to <u>N.J.S.A.</u> 40:20-1, the Board of County Commissioners of the County of Passaic ("Board") is vested with managing the property, finances, and affairs of the County; and

**WHEREAS**, the Department of Health Services ("Department") is responsible for protecting and promoting the health of approximately 525,000 residents of the County; and

WHEREAS, the Director of the Department is requesting that the Board authorize an agreement with the New Jersey Department of Human Services, Commission for the Blind and Visually Impaired ("NJDHS-CBVI"), attached hereto, under which NJDHS-CBVI shall provide visions screenings for adults and children at no cost with a concerted effort to provide such services to historically underserved sectors of the population, utilizing facilities to be provided by the Department; and

**WHEREAS**, this matter was discussed at the June 10, 2025 meeting of the Health and Human Services Committee and being recommended to the Board for approval.

**NOW, THEREFORE, LET IT BE RESOLVED**, pursuant to <u>N.J.S.A.</u> 40:20-1, the Board of County Commissioners of the County of Passaic hereby authorizes the execution of the attached Agreement with the New Jersey Department of Human Services, Commission for the Blind and Visually Impaired.

**LET IT BE FURTHER RESOLVED**, that the Clerk to the Board, County Counsel, Executive Director of the Department, and Director of the Board are authorized to take any other action necessary to carry out the purpose of this Resolution.
