**RESOLUTION AUTHORIZING THE PASSAIC COUNTY PROSECUTOR'S OFFICE TO APPLY FOR AND ACCEPT FUNDING FROM FFY23 VICTIM OF CRIME ACT (VOCA) GRANT PROGRAM, PURSUANT TO N.J.S.A. 40:20-1**

**WHEREAS**, the County of Passaic (hereinafter the "County") is a body politic and corporate pursuant to N.J.S.A. 40:18-1 and vested with all rights contained therein; and

**WHEREAS**, pursuant to N.J.S.A. 40:20-1 the Board of County Commissioner of the County of Passaic (hereinafter the "Board") is vested with managing the property, finances and affairs of the County; and

**WHEREAS**, the Passaic County Prosecutor's Office (hereinafter "PCPO") seeks permission to apply for and accept funds in the amount of five hundred fifty-three thousand seven hundred fifty-one dollars (\$553,751.00) from the FFY23 Victims of Crimes Act (VOCA) Grant Program (Subaward Number V-16-23), which is administered by the New Jersey Department of Law and Public Safety for the period July 1, 2024 through June 30, 2025; and

**WHEREAS**, the County will provide an in-kind salary/fringe match in the amount of one hundred thirty-eight thousand four hundred thirty-eight dollars (\$138,438.00), for a total project amount of six hundred ninety-two thousand one hundred eighty-nine dollars (\$692,189.00); and

**WHEREAS**, the VOCA Grant is used to cover expenses related to the County Office of Victim Services; and

**WHEREAS**, this matter was discussed by the Law and Public Safety Committee meeting and is being recommended to the Board for approval.

**NOW, THEREFORE, LET IT BE RESOLVED**, that the Board of County Commissioners of the County of Passaic hereby authorizes the Passaic County Prosecutor's Office to apply for and accept funds in the amount of five hundred fifty-three thousand seven hundred fifty-one dollars (\$553,751.00) from the FFY23 Victims of Crimes Act (VOCA) Grant Program (Subaward Number VOCA V-16-23), which is administered by the New Jersey Department of Law and Public Safety for the period July 1, 2024 through June 30, 2025.

**LET IT BE FURTHER RESOLVED**, that the County will provide an in-kind salary/fringe match in the amount of one hundred thirty-eight thousand four hundred thirty-eight dollars (\$138,438.00), for a total project amount of six hundred ninety-two thousand one hundred eighty-nine dollars (\$692,189.00).

**LET IT BE FURTHER RESOLVED**, that the Passaic County Prosecutor's Office shall use the funds received for the purposes described in the application submitted for same.

**LET IT BE FURTHER RESOLVED**, that the Clerk of the Board, County Counsel, County Administrator, Prosecutor and Director of the Board of County Commissioners are authorized to execute an agreement and take any other steps necessary to carry out the purpose of this resolution.
