The Re-Organization Meeting of the Passaic County Board of County Commissioners was held this day in the County Commissioners Board Room at 12:06 p.m.

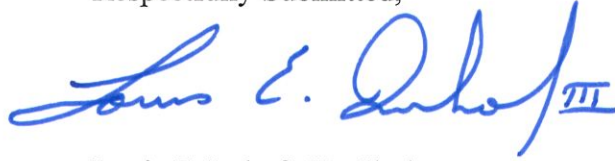
