RESOLUTION AUTHORIZING AWARD OF CONTRACT TO VARIOUS VENDORS TO PURCHASE FERTILIZER FOR THE MAINTENANCE OF THE PASSAIC COUNTY GOLF COURSE, PER BID SB-25-051, PURSUANT TO N.J.S.A 40A: 11-4, ET SEQ.

**WHEREAS**, the County of Passaic (the "County") is a government body incorporated pursuant to N.J.S.A. 40:18-1, et seq.; and

**WHEREAS**, pursuant to  $\underline{N.J.S.A}$ . 40:20-1, the Passaic Board of County Commissioners (the "Board") is vested with the powers to make all decisions on behalf of the County; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-4, et seq., every contract awarded by the County, for the provision or performance of any goods or services, the cost of which in the aggregate exceeds the bid threshold, shall be awarded only by resolution of the Board to the lowest responsible bidder after public advertising for bids and bidding thereof; and

**WHEREAS**, on April 3, 2025, the Purchasing Agent issued Bid No. SB-25-051, Fertilizers/Chemicals/Materials for the Passaic County Golf Course (hereafter "SB-25-051") seeking sealed proposals from qualified bidders for Fertilizers/ Chemicals/ Materials, for items awarded on a line-item basis, beginning June 1, 2025, and expiring May 31, 2026; and

**WHEREAS**, on April 15, 2025, bids were unsealed for SB-25-051 by the Purchasing Agent with responses from various bidders; and
