Dear Community Partner/County of Passaic, Department of Health Services:

Thank you for your interest in partnering with Mammography in Motion. This missive serves as formal confirmation that the University Hospital's Mammography in Motion commits to provide mobile mammography services at your identified location at 930 Riverview Drive, Totowa, NJ 07512. The event will take place on Saturday, May 3, 2025, between 10am-3pm.

Guidelines/Requirements:

1. Completion of the partner request form.
2. Promotional material must be reviewed and approved by UH before distribution.
3. Pre-registration of participants is required.
4. Flat parking space of 45 ft x 15 ft x 15 ft required.
5. Your organization provides a site coordinator/team.
6. A room to serve as waiting area located as near as possible to parked mammogram unit.
7. The Mammography in Motion team will arrive at least 1 hour before clinic start time.
8. Should there need to be cancellation of an event on either side, the other party must be notified by calling, then followed up in writing to the given email at least 2 hours prior to event start time.
9. The Hospital shall have an appropriately licensed/certified technologist to process the mammography digital images (film images, upon request) for reading by a radiologist within the MQSA (Federal Mammography Quality Standard Act (amended 2014) protocols and guidelines after the Hospital's services on-site.
10. The Hospital shall provide a letter to a participant advising of normal results.
11. Should a result be abnormal, the participant will be contacted and guided to next steps.

12. Hospital is a body corporate and politic, and an instrumentality of the State of New Jersey. As such, this Agreement is subject to all the provisions of the New Jersey Tort Claims Act, N.J.S.A. 59:1-1, et seq. To the fullest extent allowed by law, Hospital shall, during the Term, indemnify and hold County of Passaic, Department of Health Services (CPDHS) and its employees, agents, directors, officers and affiliated corporations and their respective officers, directors and employees (individually and collectively, the "CPDHS Indemnitees") harmless from all Claims arising out of the negligent acts of any Hospital employee in connection with the activities set forth in this Agreement; provided, however, that Hospital will not indemnify or hold CPDHS Indemnitees harmless for any Claims arising from the negligence or willful misconduct of a CPDHS Indemnatee and further provided, however, that Claims shall be brought in accordance with the timeliness and notice requirements of the New Jersey Tort Claims Act. This indemnification provision shall survive the termination or expiration of this Agreement for Claims that arose while this Agreement was in effect.
